Official Recall Notification Federal Boat Safety Act Voltage Regulator – 240 HP Jet Drive

This Bulletin replaces Mercury Outboard Service Bulletin 2000-15 and Mercury Jet Drives Service Bulletin 2000-03

Models Affected:

240HP JET DRIVES - 2000/2001 Model year product


Serial numbers: 0E370718 through 0E397308

Voltage regulators that are in use on products identified above are at risk of experiencing an electrical short. A short, if it occurs, could be an ignition source for any flammable material in close proximity to the voltage regulator.

In November of 2000, a field campaign was initiated for all 240HP Jet Drives with the serial numbers 0E370718 through 0E394131. The campaign required the replacement of the voltage regulators. However, Mercury Marine has recently learned that the potential for a short, although very remote, still exits in the replacement voltage regulators. This risk can be eliminated by increasing the rating of the fuses from 20A to 30A.

Mercury Marine will replace the regulators and/or fuses on the affected 240HP Jet Drives as described below.

- All 240HP Jet Drives that did not respond to the original field campaign will require both the regulators and fuses replaced (serial number 0E370718 – 0E394131).
- All 240HP Jet Drives that did respond to the original field campaign and those with serial numbers 0E394132 through 0E397308 will require only the fuses replaced.

Owner Notification


All registered owners with engine serial numbers 0E370718 through 0E394131 were sent letters in Nov. of 2000. They will still be responding when their boats are brought out of storage. At that time, they will receive both changes per this bulletin.

A letter will be sent to every registered owner with engine serial numbers 0E394132 through 0E397308. The same letter will also be sent to registered owners who responded to the original campaign initiated in November of 2000. The letter will advise the owner to return their jet boat to their Mercury Jet Drives servicing dealer or any authorized Mercury Marine outboard servicing dealer for the inspection/replacement. The owners will also be advised not to use their boats until it is verified that the proper fuses have been installed.


Dealer Inventory

BOATS

All boats in inventory (new or used) with 240HP Jet Drives that fall in the affected serial number range should be checked. Inspect the regulators for either a "Green" or "White" dot and/or part number (883072-1) stamped on them. Painted dots are located next to the wires exiting the regulator. The part number is located on the opposite side of where the wires exit the regulator. Also, check the fuses. If they are 20A fuses, replace with 30A as shown below.

Dear Mercury Marine Customer:

Our records indicate that you are the owner of a Mercury 240HP Jet Drive included in a recall being performed in compliance with the Federal Boat Safety Act. The voltage regulators that are on your engine are at risk for experiencing an electrical short. A short, if it occurs, could be an ignition source for any flammable material in close proximity to the voltage regulator. Mercury Marine will replace the voltage regulator and/or fuses on the affected Jet Drives.

DO NOT OPERATE YOUR ENGINE UNTIL THESE REPAIRS ARE COMPLETED.

WHAT YOU SHOULD DO

Contact your authorized dealer, preferably the one who sold you the engine, and make arrangements for inspection/replacement of the voltage regulator and/or fuses. The dealer will refer to Mercury Outboard Service Information Bulletin 2001-09 or the Mercury Jet Drive Service Information Bulletin 2001–01 for instructions. You must deliver your engine to the dealer and present this letter, the reverse side of which is a claim-form your dealer needs to send to us for reimbursement.

NOTE: If your boat is in storage, you may want to wait until you remove it from storage to have this service performed.

WHAT WE WILL DO

We will reimburse the authorized dealer for the replacement of the voltage regulators and/or fuses in line with the service bulletin.

We apologize for any inconvenience this recall may have caused you; however, we have taken this action to ensure that your boating experiences will be safe and enjoyable.
